After a long deliberation, it was resolved that

The steps taken for admission of 2019-2020 batch under GIET University 1<sup>st</sup> batch as per GIET University Act is hereby approved.

Registrar brought to the notice of the Board that due to severe cyclonic storms in the month of may 2019, (Fani), students were asked to vacate the hostels as well as asked them to move away from Gunupur as per Government instruction.

He further informed that

Severe damages were occurred in electrical installations, Mechanical Block and some of the hostel buildings in the campus. Around 250 to 300 trees were fallen down as the wind flown was from 150 Kms to 200 Kms speed and the whole campus was in dark for three days.

As a result all the examinations under BPUT were postponed to June, 2019. It took one month for restoration of all the things in place, but Mechanical Block was completely damaged. In the meantime, the UGC visit was scheduled during the month of July, 2019, but due to severe cyclonic affect , we requested the UGC Authorities to postpone the visit in the month of November/December,2019 for which they had kindly agreed.

Fortunately, the examination for other 3 batches( Two autonomous batches and one final year batches) were completed in the month of April,2019 and the students had left the campus for summer training and joining in companies respectively.

As the Mechanical Block was damaged a lot, we took a decision for construction of RCC building with G+3 in place of inclined roof. Accordingly, demolished the Mechanical Block and started construction work in the month of July, 2019 for Mechanical Engineering and other research related blocks.

Vice Chancellor placed before the Board of Governors that steps were taken to strengthen the R&D activities. In this process, 3 international conferences were planned to organize in the months of December and February for the departments of ECE, Biotech and CSE.

Further informed that the experts from UK, USA, Vietnam, Thailand, Canada have attended in the conference as session chairs along with the professors from premier institutes of India.

After a lengthy discussion all the members expressed their satisfaction for

- (i) the steps taken by the University authorities during Cyclone(Fani) period, construction of new building (G+3) for Mechanical and other research related blocks.
- (ii) organizing International Conferences in the month of December, 2019 and February, 2020 in the departments of ECE, Biotech and CSE.

Further ratified the action taken by

the President and Vice President to take up the construction work immediately before the UGC inspection.

Registrar informed the Board that

In order to maintain cadre ratio as per UGC norms and in view of UGC inspection the following faculty members were appointed in different departments to meet the Academic, R&D and other requirements.
