The minutes of the last meeting were read and confirmed.

Registrar placed before the Board of Governors, the following points for obtaining AICTE approval from the academic session 2021-22. He also emphasized the demand of different courses in the job market in view of rapid changes of the digitalization. In the process he has suggested for following changes

- (i) Registrar informed the Board that GIET University has been admitting students under supernumerary quota for OCI/Foreign Nationals/Children of Indian Workers in Gulf countries as per AICTE approval since long. It is suggested to submit application to AICTE for approval of admitting foreign nationals for 2021-22 session also
- (ii) Again he informed the Board that in view of submission of application to AICTE for increase of Seats, for opening of new course there is a need of faculty recruitment as per AICTE Norms.
- (iii) Further informed, in order to apply the above courses, we need to deposit the requisite fee as per norms.

### 3. Change in the name of affiliating University/Board.

Further he brought to the notice of the members that the name of GIET University was not reflected in the AICTE portal during 2019-20 academic session. It was shown as Directorate of Technical Education, Odisha as affiliating body. Now the AICTE has objected and asked us to show in affiliating body as "self" and ask GIET University to obtain NOC from Govt. of Odisha for change in the name of affiliating University/Board from Directorate of Technical Education, Odisha at Cuttack, Odisha 753001.



#### 4. Change in the name of the Bank.

Further informed, we need to change the name of the bank with account details in the name of GIET University as we have uploaded the accounts details of GIET MAIN CAMPUS (AUTONOMOUS) in the AICTE portal earlier.

After a lengthy discussion, it was resolved that the proposals submitted by Vice President as mentioned below in detail are hereby approved.

**6. (A) To apprise about the activities held during COVID19 period & steps taken post COVID19 period.(Academic, Administrative, R&D activities etc.)**

Registrar placed before the Board Governors that Due to corona pandemic, we were virtually organizing so many activities to run the University smoothly including conducting online classes and examinations as per UGC Norms. In fact, we have learnt so many lessons such as how to survive, manage and implement the things during the pandemic period to lead our day to day activities in the organization with the help of changing technology from time to time.

At the outset, I would like to present a brief report about the activities took place last one year followed by the other agenda points.

UGC team consisting of ten members visited our University for inspection during 9<sup>th</sup> and 10<sup>th</sup> January, 2020 and verified all documents and witnessed the facilities available in the Campus including Agriculture fields.

Organised one International Conference during the Mid month of March virtually/physically by the time a declaration was made by the Govt. of India for shut down.

University was closed from 23<sup>rd</sup> of March, 2020 due to Corona as per instructions of Govt. of India and almost all students left the Campus except a few foreign nationals. However, security and other essential services have been functioning to protect the properties & environment and also to cater to the needs of the people depended on them. Similarly, some of the core team faculty members stayed back during corona period, which had helped the University to organize different Academic and other activities virtually without any loss of mandays

Obtained funding grant of 2.50 crores from Govt. of India through (ACIC) Atal Communication and Incubation Centre), the only University from Odisha.

Successfully organized the Virtual Grand finale of Smart India Hackathon event-2020 identified us from Odisha region as only University under the guidance of AICTE, MHRD and MIC during the month of August inviting technical people both from Academia and Industry

During the pandemic period, Faculty Selection has been organized for different departments as per UGC norms. The following number of faculty members have been appointed to enrich the academic and R&D activities.

CSE – 3, ECE-1, BSH-4, Civil-01, Biotech-03, Agriculture 8 Nos. Soft skill Trainers-5 Nos. totaling to 25 nos.

As the courses for even semesters could not be completed due to shut down, online classes were conducted to complete the syllabus from the month of April and May, 2020 followed by virtual project viva, seminar and lab viva submissions. The examinations for even semester were conducted from July to till 7<sup>th</sup> of August, 2020 as per UGC norms with a relaxation that if the students who are not in a position to appear exams due to bandwidth nor satisfied with the online exam or any problem, shall be allowed off line exam once the Govt. permits us to open the University. Almost 97% of the students could appear the exams as per schedule through online. The results were published accordingly.

Virtual Classes for odd semester were commenced from 17<sup>th</sup> of August, 2020 as per academic calendar for all existing students until 12<sup>th</sup> of December, 2020. Simultaneously, approached the renowned faculty members of different institutions for question paper setting. Examinations for ODD semester have been commenced from 19<sup>th</sup> of December, 2020. The whole credit goes to the Examination team for their relentless efforts to conduct the exams smoothly and systematically during the pandemic period.

Similarly, all the HODs & their Team are also deserved appreciation as they have organized and participated in the following activities throughout the entire pandemic period :

- 1) First of all cooperating the administration in controlling the Pandemic corona as a Team member in and around the Campus premises.



- 2) Framing of syllabus for 2020-2021 batch of students (New Batch) by inviting BoS members virtually and got the same finalized
- 3) Organized FDPs, STTPs, International conferences etc.,
- 4) Involved the students to participate/attend in different events such as Chhatra Viswakarma Awards, virtual Internships and other different programs. 3 out of 5 concepts were accepted for next round Chhatra Viswakarma Awards.
- 5) Completed the evaluation of answer scripts of even semester (2019-2020 Batch) and supported the CoE and his team in publication of results in time
- 6) Arranged the review meetings for Ph.D. scholars virtually & physically and virtual presentations for new batch of Ph.D. scholars
- 7) Encouraged and Motivated the faculty members in submission of Funding Project proposals with different statutory authorities including AQIS schemes of AICTE
- 8) Arranged virtual classes through Google Meet for odd semester from 17<sup>th</sup> of August, 2020 with the help of E-class Team
- 9) Motivated the students to attend the online classes regularly with the help of proctor system
- 10) Motivated the faculty members in educating the students to attend remedial & regular classes and examinations through online by using proctor mechanism during pandemic period.
- 11) Worked relentlessly during the pandemic period for up gradation of different activities of the University
- 12) Prepared and framed syllabus and got it approved through Board of Studies meeting virtually for 2020-21 academic session for all courses of different schools.
- 13) Obtained approval from Academic Council meeting held virtually due to corona:
  - I. all proceedings of Board of Studies meetings of all courses of different schools.
  - II. Publication of odd semester results
  - III. Execution of MOUs with reputed organization.

The Team T&P, started working on virtual training classes with the help of in-house trainers, where 90% of the students attended the classes.

As a part of awareness programme about the need of industry, steps have been initiated to organize virtual HR conclaves inviting top notch people of the industries under the caption "SPOT LIGHT". As on today we have organized seven conclaves, where faculty and students have participated in a large number.

We were afraid of providing placement during the corona period, but fortunately, the corporates have changed their style of recruitment through online, for which a good number of students were selected by all reputed companies as following. Our heartfelt thanks to all of them, who have helped us in this crisis period.

They have been interacting with us either virtually or physically for betterment of different activities of the university and supported us in all aspects.

6. (B) Registrar placed before the Board of Management that as per resolution in the last meeting regarding opening of B.Sc Nursing & Pharmacy courses, all guidelines and procedures for application have been collected. A request letter was sent to Chief District Medical and Public Health officer, Rayagada for undergoing clinical/practical training of the Pharmacy and Nursing students at Sub-Divisional Hospital, Gunupur for the academic session 2020-21 on 22.11.2020.

He further informed the Board that for opening of B.Sc Nursing courses, Rs.60000/- to be deposited towards the fees along with prescribed application form attaching all necessary documents for permission to start B.Sc Nursing course from Odisha Nursing Council.

After a short discussion, all the members of the Board have appreciated the effort taken by the Registrar for opening of B.Sc Nursing course.

he is authorized to deposit requisite fees along with all necessary documents in a prescribed format as per Odisha Nursing Council norms.
