3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Gandhi Institute of Engineering and Technology University, Odisha, Gunupur (GIET University), At Gobariguda Po Kharling Via Gunupur DT Rayagada Odisha-765022** as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programs accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.
